Lyons is expanding the voluntary recall due to the potential for microbial contamination, including from the organisms *Cronobacter sakazakii* and *Clostridium botulinum*. Although *Clostridium botulinum* has not been found in products, consumers are warned not to consume any of the recalled products. While infection related to *Cronobacter sakazakii* is rare, the common symptoms of illness could include fever, vomiting and urinary tract infection. *Clostridium botulinum* may cause a severe form of food poisoning. It can begin from six hours to two weeks after eating food that contains the toxin. Symptoms may include double vision, blurred vision, drooping eyelids, slurred speech, difficulty swallowing, and muscle weakness. Botulism poisoning can cause respiratory paralysis, resulting in death, unless assistance with breathing (mechanical ventilation) is provided.

Please immediately examine all inventories and return or destroy any product that may still remain in your possession. If you have further distributed this product, please identify and notify your customers of this product recall and instruct them to return or destroy this product immediately. This recall should be carried out to the end consumer level.

Finally, if you destroy rather than return product, please confirm as soon as possible to manish.kulkarni@katefarms.com that you have followed the instructions provided in this notice and provide quantities, lot code, and expiration date of all product destroyed.
